COVID-19/Vaccination Requirement

2. Please note that Whisky Journey 2022 is a vaccinated-only event. You will still be required to show valid proof of vaccination as a condition of entry into the venue. Individuals who are not fully vaccinated will be denied entry.
3. You may also be required to comply with any additional covid-19/epidemic measures put in place by the authorities at the time of the event. You acknowledge and agree that failure to do so may result in you being denied entry to the venue without any compensation.
